ORDINANCE NO. 2026-20
AN ORDINANCE
AUTHORIZING THE
ISSUANCE OF GENERAL
OBLIGATION BONDS OF
THE CITY OF HUTCHINSON,
KANSAS, FOR THE
PURPOSE OF PAYING THE
COST OF DEMOLISHING AN
UNSAFE AND DANGEROUS
STRUCTURE FOR PUBLIC
HEALTH AND SAFETY
PURPOSES, ALL PURSUANT
TO ARTICLE 12, SECTION 5,
OF THE CONSTITUTION OF
THE STATE OF KANSAS.
WHEREAS, the City of
Hutchinson, Kansas (the
"City"), is a duly organized
city created and existing
under the laws of the State
of Kansas;
WHEREAS, the Governing
Body of the City has
previously determined that
the structures located at
211 E 4th Avenue
(collectively, the
"Structures") are unsafe and
dangerous;
WHEREAS, the Governing
Body of the City has also
previously determined that,
in order to promote the
health and safety of the
City, it is necessary and
desirable to demolish the
Structures;
WHEREAS, the Governing
Body of the City now finds
and determines that it is
necessary and desirable for
the City to finance the cost
of demolishing the
Structures, including
asbestos removal,
demolition of accessory
buildings, and debris
collection, with the issuance
of general obligation bonds
of the City, and that the
issuance of such bonds will
promote the health and
safety of the City;
WHEREAS, pursuant to
Article 12, Section 5 of the
Constitution of the State of
Kansas (the "Home Rule
Amendment"), the City has
authority to determine its
local affairs and government
except when limited or
prohibited by an enactment
of the state legislature
applicable uniformly to all
cities of the same class;
WHEREAS, the Structures
are located within the
corporate boundaries of the
City or within three (3) miles
of such corporate
boundaries, and promotion
of health and safety at the
site of the Structures is
within the local affairs and
government of the City; and
WHEREAS, no statutory
authority exists to limit or
prohibit the exercise of the
City's authority under the
Home Rule Amendment to
finance the demolition of
the Structures through the
issuance of general

obligation bonds:
NOW, THEREFORE, BE IT
ORDAINED BY THE
GOVERNING BODY OF THE
CITY OF HUTCHINSON,
KANSAS, AS FOLLOWS:
Section 1. Pursuant to the
Home Rule Amendment, the
Governing Body authorizes
the issuance of general
obligation bonds of the City
in an amount not to exceed
\$235,000, including costs of
issuance, to finance the cost
of demolishing the
Structures.
Section 2. This Ordinance
shall be in full force and
effect after its passage by
the Governing Body of the
City and publication as

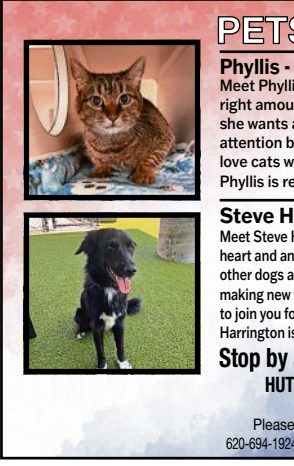

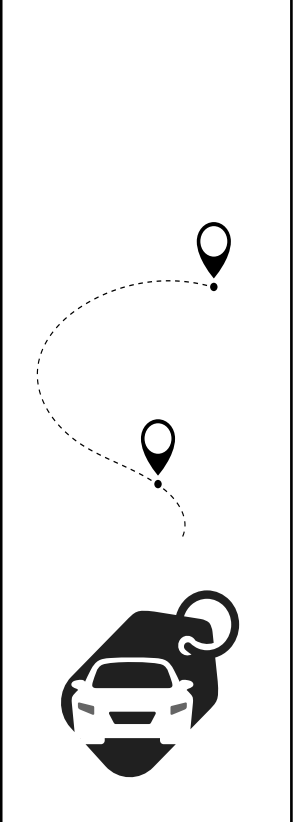
